- ★ Wisconsin driver license*
- ★ WI DOT-issued photo ID card*
- ★ U.S. passport*
- ★ Military ID card*

**The above documents may not have expired earlier than the date of the last November election (11/6/18).*

- ★ Certificate of naturalization issued within last 2 years
- ★ Unexpired Wisconsin driver license or state ID receipt
- ★ ID card issued by a federally recognized Indian tribe in Wisconsin
- ★ ID issued by a Wisconsin accredited university or college—must contain issuance date, student signature, and expiration date within 2 years of issuance, along with proof of current enrollment (can be expired).

Photo ID



Photo Identification Required

Wisconsin law now requires voters to present a photo ID before obtaining a ballot.

Your photo ID does not need to show a current address. Election officials will only be looking at the type of ID presented, the name, photograph, and the expiration date.

Absentee Ballot Requests

Mail/E-mail

Absentee requests sent by mail or email must be accompanied by a photocopy of an acceptable form of photo ID.

Once a photocopy is on file, you will not need to provide with future requests, unless you move or change your name.

Please read your absentee ballot instruction letter very carefully. We want your vote to count!

In-Person Absentee Voting

Absentee voters casting a ballot in the City Clerk's office must present a photo ID just as they would if they were voting at the polls.

Photo ID Exemptions

Photo ID is not required for the following absentee voters:

- Military voters
- Voters who are permanently overseas
- Confidential Voters
- Indefinitely confined voters
- Nursing home residents and other voters who have ballots delivered by Special Voting Deputies
- Residents of Care Facilities who are not visited by Special Voting Deputies

Hospitalized Voters

Hospitalized voters must appoint an agent to pick up their ballot from the Clerk's Office. The agent needs to bring their photo ID, the hospitalized voter's photo ID, and the absentee ballot request to the Clerk's Office. Please call 608-821-8350 for more information.

Provisional Ballots

Voters unable to provide an acceptable form of photo ID on Election Day will become provisional voters.

Provisional ballots are not counted

unless the voter provides the City Clerk's office with an acceptable photo ID by 4 p.m. the Friday following the election.



Documents Needed to Obtain a Free ID

In order to receive a free ID card from the DMV, you will need to check the box on the application indicating you need an ID for voting purposes and you will need to present the following documentation:

Proof of name and date of birth

Examples:

- US Passport or card
- Certified birth certificate
- US Certificate of naturalization

Proof of identity

Examples:

- Driver's License/ID Card
- US Passport or card
- Military ID card
- Social Security card
- W-2 form

Proof of Wisconsin residency

Examples:

- Paystub
- Utility bill
- Mobile phone bill
- Bank statement
- Home, renter, auto insurance (original)
- Deed/lease (original)
- Hunting/fishing license (original)
- WI Driver's license/ID card

Proof of U.S. Citizenship

Examples:

- US Passport or card
- Certified birth certificate
- US Certificate of naturalization

Social Security number

Examples:

- Social Security card
- W2 with full ss#
- Paystub with full ss#

Dane County Fees Waived

If you were born in Dane County and need to obtain your certified birth certificate to apply for a Wisconsin ID to vote, the Register of Deeds will waive the fee. You will need to provide two documents with your name and address, or bring along a family member who has photo ID to corroborate for you.

Unavailable Documentation

If you are applying for a free ID card for the first time for voting purposes and your documents to prove U.S. citizenship, name and date of birth, or legal name change are unavailable, you may file a [Petition with the DMV](#). You will be issued a temporary ID receipt which is acceptable form of ID for voting purposes.
